

## Notes

You must pay an amount of income tax and/or capital gains tax at least equal to the tax that all the charities or Community Amateur Sports Clubs (CASCs) that you donate to will reclaim in the tax year (currently 25p for each £1 you give). Other taxes such as Council Tax and VAT do not qualify.

You can cancel this declaration at any time by notifying the charity.

If in the future your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that the charity reclaims, you can cancel your declaration.

If you pay tax at the higher rate you can claim further tax relief in your Self-Assessment tax return.

If you are unsure whether your donations qualify for Gift Aid tax Relief, ask the charity. Or ask your local tax office for leaflet IR 65.

Please notify the charity if you change your name or address.

Spouses can make a joint declaration and joint donations will be split equally between the donors, unless otherwise instructed.
